BOD meeting 9/8/2020-Treasurer's Report submitted by Holly Tilson

The Monthly Expense Report (MER) may not be ready for the BOD mtg because of the holiday so the expenses are included below.

Background: The city gave each Neighborhood Council (NC) \$32,000 this year (previous year was \$42,000)

A new policy allowed NCs to encumber funds because of the covid shutdown in March. We encumbered \$3100 of our remaining balance of \$9040

- -\$2500 the balance due to The Web Corner for website upgrades
- -\$600 for the bus bench advertising

All NCs can carryover up to \$10K, our carryover is \$5940. As of this morning the carryover has not been added to our budget sheet by the city. It should be added to our budget next month. (They were having some glitches in their program)

Tonight's funding motions: The city asked that we again have a motion for the web corner expenditure changing last month's motion from "encumbered" to "accrued". The rationale was "because the contract was in process". I don't really understand this rationale completely but that's what the city wanted. We still need to use it for the designated purpose or it returns to the city.

Budget Changes: There was some discussion with our funding rep regarding the encumbered funds and whether or not they should be on our budget sheet, (last month, I was told to add them). She wants us to use a grand total of \$37940 (\$32000 + \$5940, the carryover) and leave off the \$3100, the encumbered funds. My funding page shows the \$3100 on it but not the \$5940. Her page doesn't show either. Because of the "glitch" in the program no changes are being made this month.
