4. APPROVAL OF THE MINUTES
 - 4.1. OCTOBER 6, 2022 - Approval of these minutes moved by Paul, seconded by Myhra, approved without objection.
5. CHAIR REPORTS
 - 5.1. Chair – Jordan Paul - None
 - 5.2. Vice-Chair – Faith Myhra -
 - 5.2.1. I attended the NCSA Transportation Committee and got good advice on how to go about getting more EV chargers. It was suggested it would be too difficult to try to get them at the MV Post Office due to it being federal property but that we could reach out to the council office for help. I will reach out to both CD11 and CD5 and report back.
 - 5.2.2. We have got notice that construction on a pedestrian signal at Sepulveda and Clover Ave has broken ground and should be up by the end of the month. The dangers of this crosswalk was brought to our attention by stakeholder, Samuel Lutzker. Our committee passed a motion asking for a pedestrian signal at our February 2nd, 2022 committee meeting and then passed the February 16th, 2022 Board meeting.

5.3. WRAC Report – Andy Perrine - Andy attended their first WRAC MTC meeting in October. Part of the meeting was getting them introduced to the committee and up to speed.

5.3.1. There were some WRAC motions that were outstanding, they need to be internally adopted by internal procedure. A certain number of member councils need to adopt them before moving forward. They believe there have been similar MVCC motions in the past but nothing in this current Cycle for the two.

5.3.2. The big discussion was the Sepulveda pass corridor. MVCC brought up this topic when it was undergoing the public comment period and submitted a motion in support of a connection to the purple line and a UCLA stop. After public comment, the project came out with a graphic displaying the large margin of comments. It took a lot of public feedback and made it into a handy area chart of comments that touch on a few popular items. Currently it is not necessarily a public comment period in the project. At the same time, there is a lot of public discourse happening. The reason Andrew Lewis of North Westwood Neighborhood Council introduced it to the committee was to allow neighborhood councils to weigh in on this upsurge in commentary from people in Beverly Hills, in the Valley, and Leaders at UCLA. There is heavy pressure against the heavy rail option. The heavy rail option would fulfill the motion we passed in support of the UCLA connection or at least make it a lot more difficult because a lot of these forces are lining up for the monorail options that are either indirectly connected to UCLA through a transfer or through a sky bridge.
