Mr. Diede, Ashley et al;

1. Yes. The sand pile is still there. It's 10:30pm Friday, and raining hard, 2 days of rain, a hail storm and I'm sure no one has taken a single bag. The pile is as high and wide as when it was dropped.
2. Relocating. FD #62 is on 2 boulevards, Venice Blvd and Inglewood Blvd. The sand pile could go onto the FD side of either of those Boulevards. But if it blocks the ingress/egress, then it could go Inside the massive parking lot of FD 62.

This sand pile is now the talk of the immediate neighbors! And as [REDACTED] mentioned, we were completely unaware of why it was placed there originally. No communication or notice. Most of us, including myself, thought it was for Venice Blvd street work... or perhaps FD was doing something productive with it for landscaping. It sat there untouched for a month until I emailed Capt. Penrod (with pictures) and was made aware it was for community use, and so the request was made to have it relocated back in November, 4 months ago! And, as [REDACTED] mentioned, we didn't even know about the FD having the bags, IF anyone wanted them. [REDACTED] offered for us to bag sand up and this learned bags are within the FD for the asking.... No one knew/knows that. No communication or notice. Well some people now know... it's been discussed by neighbors since we bagged up the first pile and posted it in apps for people to pickup.

Ironically, if anyone DID want sand, and drove by the fire department to look for the sand, it is not visible to them anyway on the main sides of FD 62! It's sitting within the residential area (all single family homes) of the Mar Vista Oval, by the back corner of the FD - completely out of view of any passerby or prospective "needing person" who drives to the FD searching for it.

[REDACTED] and I regularly maintain the FD Marcase side of the parkway. VERY REGULARLY! We clean up the trash, pick up and pile together the fallen palm tree fronds, we clean up the alley way immediately behind the FD. We upkeep these areas since no one does it regularly - because we care about OUR neighborhood, community and our street. I live directly across from FD 62 so I often do this... so the eye sore of a sand pile is really obtrusive to what little (none) landscape exists on the property of FD.

Note: I took the time to look at the FD website, and FD #62 is not listed as providing Sand. (Palms FD #43, 1.75 miles from here does show up on the LAFD website list, and I know for a fact has sand visible near their Main Door, and Car driveway area. ** No communication, no notice**)

Hi Gaby,

I hope this email finds you well. I wanted to update you on a project that I am working on with Carlos. We recently conducted a site visit with his team and Captain Ryan Penrod at the Mar Vista Fire Station, and we have identified an opportunity to beautify the landscaping on the side of Fire Station #62.

While we are excited about this project, the cost is larger than the 5K that we can allocate through an NPG. However, Carlos mentioned that the fire department is looking into obtaining free supplies through LADWP. Additionally, we were wondering if it would be possible to utilize a few of the days that are allocated to CD11 from Carlos's team each month for weed removal to help stretch the budget further?

Assuming everything gets approved, we were also hoping that Traci would consider mentioning us in her weekly newsletter to help gather community volunteers for the installation and to keep labor costs down.

Please let me know your thoughts on this project and if you have any suggestions for how we can move forward.

PROJECT PLANS

PROJECT PLANS Con't

STEP 1 Purchase • 2x4x8's
 9 pieces → 2 benches
 • 2in deck screws
 • 2 1/2in deck screws

STEP 2 Use chop saw to cut (in inches) the following:
 2x4x8: 13.5 | 13.5 | 11.5 | 9.5 | 9.5 | 11.5 | 13.5 | 13.5
 half 2x4x8: 13.5 | 13.5 | 11.5 | 9.5

STEP 3 Use table saw (or router) to cut ^{1/2 in} deep groove in leg posts.
 * By running over the table saw multiple times and then using a chisel to break off and smooth out you can create a groove a 2x4 piece can slide into
 How high from ground?

STEP 4 Connect the leg pieces using wood glue and deck screws
 * drill pilot holes to prevent the wood from splitting

STEP 5 Space out top pieces using ~ 0.25in spacers along length (scrap wood) and clamp together

STEP 6 Place legs on top and attach using wood glue and deck screws.
 IMPORTANT: ONLY SCREW FROM BOTTOM EXCEPT AT END TO HOLD EDGES IN PLACE
 * drill pilot holes
 * remove spacers when all legs are in place

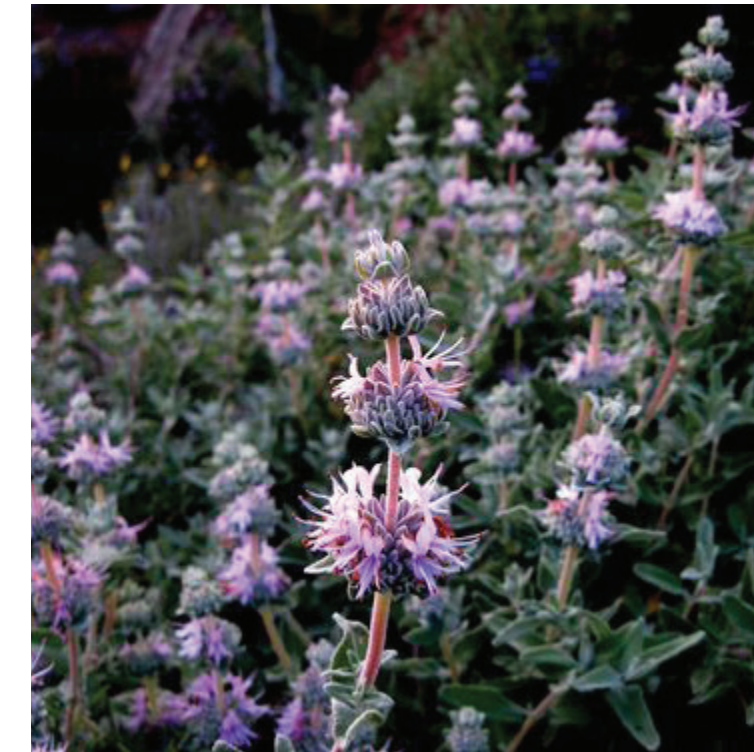
