7.1 [POLICY] Elected Representative, Government Agency, and City Department Reports a. MAR VISTA CRIME UPDATE – Presented by LAPD SLO KARWON VILLERY

Officers Acosta and Villery are present: Senior Lead Officers Acosta (Palms) and Villery (Mar Vista)

Three Main Crime Concerns:

- I. Residential burglaries
 - A. Burglary crew: they were arrested in May, but are striking again.
 - B. There have been 95 Burglaries as opposed to half that number at the same time last year
 - C. Breaking sliding doors
 - D. Most occur between noon and 6pm
 - E. Mar Vista is currently a mission area, meaning more saturation by police
- II. Nighttime garage burglaries
 - A. Mostly attached garages
 - B. Targeting multiple garages
 - C. Culver City is not ready to move on encampment
- III. Catalytic Converters
 - A. Mostly Prius'
 - B. 48 this year compared to 26 last year

Venice/Globe Encampment

- I. This is an extra wide sidewalk
- II. Two districts and one city (Culver City) involved.
 - A. They have to work together
 - B. Recommended with calls and emails to CD 5
 - C. They are cleaning it every 10 days, but they come right back.
 1. Care - clear up things that are voluntarily surrendered
 2. Care Plus - residents get notice and can pick things up before they are removed
 - D. 48.18 is not a fail safe to resolving the issue

Patrol Limitations

Only 8 patrol cars in 28 square miles. They are operating on the same pattern of car patrols that were developed in the 1990's. No new officers were added with Playa Vista development.

LAPD is below 9000 officers, and includes command staff and 200 in the academy.

Community Actions to Take

1. *We need to be Force Multipliers:*
 - a. *Be a good witness*
 - b. *Write to chief of police about concerns*
 - c. *Neighborhood Watch - a block captain works directly with Senior Lead Officer*
2. *Things for Committee to consider*
 - a. *Invite a detective supervisor to the meeting to discuss issues with us*
 - b. *Create a resolution pertaining to concerns of stakeholders regarding safety*
