4. ELECTED REPRESENTATIVE, GOVERNMENT AGENCY AND CITY DEPARTMENT REPORTS

<u>Michelle Persoff</u> - Assembly Member Isaac Bryan office, senior field rep; Monday - Town Hall.

AT&T landline issue - encouraged people to make voices heard about whether they want landlines discontinued.

Seven out of 12 insurance companies have left California. Log a complaint with the Department of insurance if you have concerns. - Assembly Member Bryan's office can be a resource.

Chair of Natural Resources

Bill 27.16 - if you are producing less than 15 barrels a day in the last two years, you have to cap or clean up the oil well, or you will be fined.

Director Greenwald at 6:40 arrived: no ex parte or conflicts.

<u>Matt Halden</u> - Field deputy for Mar Vista for Traci Park's office. Tabled an event at the Farmer's market and is getting to know the community. Updates on the Mural project are upcoming.

Mary Ensley - Mayor Bass' office- share concerns about community safety - QR code available. Interim Chief of LAPD has been sworn in. 1,200 applications have come into LAPD. Inside Safe- they are receiving calls regarding homelessness and RV encampments. Deputy Mayor of Homelessness has been brought on. Highlighted 311, they are doing overhaul. Mayor just returned from Paris regarding small business growth as it relates to the 2028 Olympics.

<u>Janet Turner</u> - sent an update from Ted Nieu's office. Rep. Lieu secured over \$11 million for local community projects for FY24. Of these,

- \$840,000 was for the remodeling of the Venice Beach Bathrooms.
- \$500,000 was for the Lincoln Neighborhood Corridor Safety enhancements that includes bike lanes and pedestrian safety measures.
- \$1million for homeless housing projects.

Last year the projects had to have an infrastructure element. it was required that any request be submitted through a government agency or department. The project needs to be able to go forward even if the funding does not come through. We have alerted your City Council Office that soon we will be asking them to submit requests. We are still waiting guidelines for FY25 projects. We suggest that if there are projects that your community would like them to consider submitting to us that you reach out to them.

<u>Prabjhot Chamber</u> - training updates: anti bias training, gender expression/gender identity training are mandated now; 90 days to complete. Board of Neighborhood Commissioners update code of conduct policy. Training on Cornerstone Account. Women's leadership even on March 28th at City Hall. Registration is closed.
