Funding Motion- Where as MVCC has a budget of \$2,000 for NPGs; and Where as this will provide an opportunity for the youth of the Mar Vista to engage in community building experiences; The MVCC Education, Arts & Culture Committee will ask Mar Vista public schools via e-flyer to submit applications of proposals, created by their students, with a focus on: Public Safety, such as intolerance, sexual harassment/assault, bullying (emphasizing healthy relationships), etc., or Community Bridge Building, such as youth/seniors, immigration issues, LGBTQ issues, cultural diversity, inclusion, homelessness, etc. Proposals will be submitted no later than November 6 with a suggested budget range between \$100-\$800. Each school may submit multiple applications. E-flyer will include a link to the criteria to meet NPG requirements.
