Agenda items for discussion are as follows:

**LADOT Agenda Items:**

**Old Business** –

Item #1: Further report /updates on an LADOT crosswalk study re: a stakeholder's request for a crosswalk at Barrington & Sardis, and also a DOT study for a possible traffic signal installation with a crosswalk at Sawtelle & Graham Place in 3-5 years if approved. [LADOT]

Item #2: Re: a stakeholder's report that a left turn signal from Sepulveda Blvd. turning west onto Venice Blvd. doesn't work during the most congested periods at the intersection, and that only one or two vehicles are able to make the turn before a green light requires them to stop for oncoming traffic. Follow-up report as to Rudy G.'s order sent to a field crew to check the pavement loops and controller sensor for repair problems and whether the signal is now working again as intended. [LADOT]

**New Business** –

Item #1: Stakeholder request for a crosswalk to be installed and painted between 3415 Sepulveda Blvd. and Rose Ave., to provide a safe street crossing for pedestrians who currently cross illegally at serious risk (and also end danger for drivers at that location). [LADOT]

Item #2: Request from stakeholder Roberta Hamovitz for a traffic study (for 4-way traffic lights a Sawtelle Blvd. (by the 405 off-ramp) and 4-way lights at Olympic Blvd. and Barrington), to provide control of current and future increasing traffic dangers and congestion (issues in this area as residential and commercial building construction increases). [LADOT]

Item #3: Stakeholder John Evans requests a traffic survey, raised bumps, limit lines, and enforcement of the 25 MPH speed limit and the STOP signs on Federal Ave. between National Blvd. and Stanwood Drive. He says that Federal Ave. between National and Stanwood is "a speedway between about 4-7 p.m. and also during morning rush hour with westbound traffic Rose Ave, that turns north on Colbert." Item #2: Report from Hannah L. about foul odors and insect and rat infestations that reach neighboring houses and are created by management of an apartment building located at 3101 Barrington Ave. who place their trash and recycle bins on the other side of the alley so they can rent their alley space for high rent parking spots.
