Neighborhood Council membership is open to all Stakeholders. A "Stakeholder" shall be defined as any individual who:

- (1) Lives, works, or owns real property within the boundaries of the Neighborhood Council; or
- (2) Is a Community Interest Stakeholder, defined as an individual who is a member of or participates in a Community Organization within the boundaries of the Neighborhood Council.

A "Community Organization" is an entity that has continuously maintained a physical street address within the boundaries of the neighborhood council for not less than one year, and that performs ongoing and verifiable activities and operations that confer some benefit on the community within the boundaries of the neighborhood council. A for-profit entity shall not qualify as a Community Organization. Examples of Community Organizations may include Chambers of Commerce, houses of worship or other faith-based organizations, educational institutions, or non-profit organizations.

[The definition of "Stakeholder" and its related terms are defined by City Ordinance and cannot be changed without City Council action. See Los Angeles Administrative Code Section 22.801.1]

# Article V GOVERNING BOARD Section 1: Composition

**Number of Directors:** The Board shall be comprised of <u>sixteen (16)</u> Directors, including the five (5) officers described in Article V. Of the <u>sixteen (16)</u> Directors, one (1) shall be elected "Community" Director, <u>one (1) shall be elected "Youth" Director,</u> seven (7) shall be elected "At-large" Directors and seven (7) shall be elected "Zone" Directors.

**Section 1: Administration of Election** 

MVCC BYLAWS APPROVED 1.24.2024

**Election of Directors:** The MVCC'S Election of Directors shall occur based on a two year cycle and shall be conducted pursuant to City ordinances and procedures pertaining to Neighborhood Council elections.

#### **Section 2: Governing Board Structure and Voting**

- A. The "Community" Director shall be elected by all Stakeholders as defined in Article IV.
- B. The "At-large" Directors shall be elected by Stakeholders who live, work, or own real property or a business within the stated boundaries of the MVCC; and
- C. The "Zone" Directors shall be elected only by Stakeholders who live, work, or own real property or a business within their respective stated geographic Zone boundaries.

#### **Section 3: Minimum Voting Age**

Except with respect to a Youth <u>Director</u> Seat, a stakeholder must be at least 16 years of age on the day of the election or selection to be eligible to vote. <u>To vote for a Youth Director a stakeholder must be at least 14 years of age.</u> [See Admin. Code §§ 22.814(a) and 22.814(c)]
