IN CONFORMITY WITH THE OCTOBER 6, 2023 ENACTMENT OF CALIFORNIA SENATE BILL 411 (PORTANTINO) AND LA CITY COUNCIL APPROVAL ON NOVEMBER 1, 2023, THE MAR VISTA COMMUNITY COUNCIL MEETING WILL BE CONDUCTED VIRTUALLY.

Every person wishing to address the Board must dial (669) 900-6833, and enter 846 6660 9891 and then press # to join the meeting. When prompted by the presiding officer, to provide public input at the Neighborhood Council meeting the public will be requested to dial *9 or use the Raise Hand option, to address the Board on any agenda item before the Board takes an action on an item. Comments from the public on agenda items will be heard only when the respective item is being considered.

Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to 1 minute per speaker, unless adjusted by the presiding officer of the Board.

SB 411 Updates:

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.

Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.

(i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph, to provide public comment until that timed public comment period has elapsed.

(ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.

(iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to one minute per speaker, unless adjusted by the presiding officer of the Board.

4. ELECTED REPRESENTATIVE, GOVERNMENT AGENCY AND CITY DEPARTMENT REPORTS

Janet Turner, Office of Congressman Ted Lieu: Congressional Act challenge reception was on 12/2/2024. Highschoolers submitted proposals for scientific projects. Congress is being called back during the holidays, there will be more news next time.

Michelle Persoff, Office of Assemblymember Isaac Bryan: New legislators were sworn in yesterday. District surveys were sent out, you can still request one if you did not receive it in the mail. DOJ is getting increased funding in anticipation of the new administration intruding on the rights of Californians. Christmas in the park event is on 12/22.

Marian Ensley, Office of Mayor Karen Bass: Chief McDonnel was sworn in. Office is trying to provide more highlights and updates through the community engagement team.Citywide cleanups will begin in 2025, pull communities together to clean up the community, likely end of January. 2025 homeless count will take place on 1/21 and 1/23. Inside safe operation occurred last month, including RVs, 15 demolished and towed. Task force is trying to create a safe parking lot and create RV disposal methods.

Charles Miller, CD5 commissioner for urban forestry, member of Palms NC.

Matt, CD11: Venice Blvd. bistro lights are ready to go. Bureau of Street Lighting still needs to respond, but there should be a comprehensive update in January. The contract is not ready to go yet. There is a black van parking on Venice Blvd. by the highschool. It is very noticeable. It has been reported to Matt that they have a chop shop and lots of bikes. LAPD has been notified. The Circle team made contact with the individual living in the van but they were not open to receiving services at this time. They seemed open to moving their car every 72 hours. Another individual is by where Centinela and Palms intersect. They had a lot of garbage. Circle was sent out and made multiple contacts with the

individual, but they refused services. They were encouraged to clean up and said that they would. They were also encouraged to relocate, and now they are gone. There is no mandate to force any people into shelter. He is continuing to work to address the encampment by Palms and Sawtelle in the creek area. The gates are not secured very well and people keep getting back in. 12/14 at 2PM there will be a holiday party at the office. Send Matt an email to RSVP!

Public Comment

Charles Miller: I wrote a lot of the language in this motion. CD5 added a lot of extra language as identified that was never intended to be part of it. The entire motion was stricken to simply be a resolution supporting Monarch Butterflies in Council committee. Urban forestry was the driving force that defeated this. Charles recognizes that this council file is dead but we can work together to start a new one. He recommends that we table the motion.

Kalani: Strongly supports what Charles said. He is highly regarded as a person very familiar with indigenous plants and environmental concerns throughout the West Side. Use Charles as a resource in the future. This should be tabled but worked on separately.

Kevin Wheeler: With Charles' statement, we could still write a community impact statement with our opinion, while still pursuing it in the future.

11.2. [POLICY] [T&I] Dwell Recall For Signals / Grade Rail Lines / Bus Rapid Transit Lines / Reducing Signal Delay / Transit First Policy - Discussion and possible action regarding <u>Council File 24-1222</u> addressing signal timing for transit to ease congestion. Coincides with CF 23-1210.

Public Comment

Kalani: Opposes this motion, traffic has to stop for trains already. The only time the trains stop is if someone is being raped or murdered. We should be more focused on safety than when the trains stop.

Cian: Bus rapid transit will not effect any of us on the westside. Metro only has two of these lines which do not pass through Mar Vista. The segment that Derl is talking about is between 17th street and Colorado in Santa Monica.

Spencer: Trains should not stop for traffic and helping public transport would be beneficial for all of us, especially those that cannot drive.

Board Comment

Jakob: Current train crossings in Mar vista would not be changed, they already have priority for trains. This would make trains faster downtown and in Santa Monica, and make the E-line far more useful for commuting. Once the train becomes potentially faster than taking a car on the freeway, people will take trains instead of cars, thus reducing traffic and saving time. Additionally, making the train faster will increase rideshare, increasing safety at stations and on trains.

Carolyn: Cannot imagine how this is practical. No matter how much you say we shouldn't be driving cars, the cars won't be able to get anywhere.

April: The bottlenecks are downtown and Santa Monica, the bus lane in the valley is the one that could have an effect on commuters there.

11.3. [POLICY] [T&I] Gas, Diesel, Fossil Fuel Pumps / New Building And Permit Prohibition / Zero Emissions Vehicle / Non-Fuel Related Facilities / Los Angeles Municipal Code / Amendment - Discussion and possible action regarding <u>Council File</u> <u>21-0533</u> that has had little movement until recently, addressing the construction of new gas stations in LA.

Public Comment

Charles Miller: Wrote the Palms CIS. This was produced in a think-tank at CD5 three years ago, it is slated to expire early next year. This would not disallow the replacement of existing pumps if done under the same existing permits. Every new station that we put in that is a gas station creates a new threat to our water system, because they always leak. The City Council has been very timid about taking a vote on this.

Kalani: Supports. Would also like this to include more charging stations in the parks and libraries. Right now very few people are investing in building new gas stations, so this wouldn't cause too many issues. Gas stations are not profitable to build right now given the environmental impact. April: Voted against this in committee and tonight because the free market should decide where gas stations are. Underserved communities could be impacted.

Carolyn: Newsom is really shoving electric down our throats. We should have choices, and gas cars should be one of them. We don't have enough charging stations.

Kevin: Agrees with April and Carolyn, we are not quite there yet with the EVs and availability and affordability. Limiting supply of gas stations will raise prices.

Andrew: This is government overreach and will do bad things.

Jakob: This is not a strong motion, it merely recommends a feasibility study about banning the building of new gas stations, and would still allow for currently standing gas stations to be renovated using an existing permit. We should honestly be taking more drastic action given the effects of climate change. We are one of the most developed nations on the planet and it is our responsibility to take charge in this fight. With the new administration likely rolling back federal environmental protections, it is especially important for us as Californians to chart the path forward for the rest of the world using our great resources and ideas.
