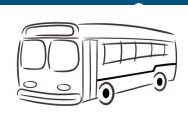

# To keep on your radar (November 2024):

---

- The City Council approved the fast-tracking of permit applications for the installation of pre-approved bollards in the public right-of-way in areas of the City where there is a risk of vehicle ramming attacks against buildings or pedestrians. This motion was pushed forward by several neighborhood councils and is important for safety ahead of the many big events coming to Los Angeles in future years. Read more [here](#) and [here](#).




Bus lane camera enforcement began on November 1st. If you're not familiar with this, Metro has officially started using on-bus cameras to issue warnings to drivers parked in bus-only lanes or at bus stops. Right now, this initial phase is limited to lines 212 and 720. Through the end of 2024, drivers will be receiving mailed warnings; come 2025, drivers will begin to receive \$293 citations. # To keep on your radar (August 2024):

---



- **Neighborhood Cleanup was a huge success!** We had ~20 volunteers show up, picked up roughly 200 lbs (!! ) of trash, enjoyed complementary coffee and tea from Alana's, relied on donations from CD11 and Mar Vista resident Rob Kadota, and met multiple new neighbors who signed up to help for future clean-ups.
- **West Pico Drill Site** The Energy and Environment committee unanimously approved the motion to direct the Board of Public Works to terminate the franchise agreement for pipelines that exclusively serve the West Pico Drill site. CM Yaroslavsky has not scheduled the motion for consideration by the full City Council yet because her office is working with the site operator on a plan to permanently close the drill site (yay!) and develop an expedited timeline for safely capping the existing wells. Reach out to her office if you want to stay tuned for future info! We discussed this CF in July 2024.
-  **E-Bike Rebate Program** On August 9, LADWP reported to the Energy and Environment Committee on this potential program. The Committee moved ahead a directive, brought by Councilmember Blumenfield, for DWP to create the rebate program and work with local CBOs on implementation. This is another CF we discussed last month!
- Rock Miller and Jarrett Thompson weren't able to join us this month. We've rescheduled them to join us in September and October, respectively!

- **Next month, our meeting will be on August 21st.** We already have several speakers lined up, including Rock Miller who will give us an overview of the history of the bike lane, Jarrett Thompson from CD5, and Jeff Khau from CD11.
- **Updates from the recent Sepulveda Transit Corridor** Out of all submissions received during the spring meetings, there was overwhelming support to eliminate Alternative 2. This means that Metro will continue with environmental analysis for the 5 remaining alternatives (2 monorail and 3 heavy rail).



# To keep on your radar (June 2024):

- **Updates from the recent Sepulveda Transit Corridor** Spring Community Meetings in mid-May. The recording and recent presentation have been updated [here](#), and the project team is compiling public comments that will be shared out via an upcoming report.
- **Updates on the Negligent Operator Treatment Act (Senate Bill 1509):** “The City Council voted to officially support Senate Bill 1509, which was introduced by State Senator Henry Stern. If enacted, the bill would increase consequences for drivers who exceed the speed limit by 26 miles per hour or more, increasing the penalty to a two-point violation. Protecting the lives and well-being of our residents is a top priority, and this legislation is a significant step towards achieving safer streets for all.”



# 2023-2024 in review:

---

- **We met 9 times** (skipped July, September, and December)
- **Held our first community event**, a Neighborhood Cleanup Day, and members from our Committee attended more:
  - Ciclavia on Venice Blvd.
  - Coffee with Assemblymember Isaac Bryan
  - NCSA general and committee meetings
- **Guests:**
  - Public agencies (Community Forest Advisory Committee, Jarrett Thompson (CD 5 Transportation Deputy))
  - Nonprofits (Resilient Palisades)
  - 3 members of the public presented issues before the Committee (including a high schooler)
- **Initiated 6 of 9 CIS' [filed by the MVCC](#)** this year
  - Alternative sidewalk corrective measures (diamond cutting) has still not been scheduled in committee/Council
  - Gas-powered leaf blower enforcement has been deferred in committee to a later date
  - The 4 other motions have been adopted by City Council
- **Sent 4 letters** of grievances/requests to Council offices and public agencies
  - Sawtelle crosswalk request
  - Flo EV charging station parking enforcement and signage
  - Alignment of the LADOT Westside Mobility projects
  - Transparency around the street hump application cycle
