attended an EACC meeting in 2024, has brought some new sculptures back up in the Mar Vista area. There are six so far, along Palms, Marco, and Maplewood. These are on approved poles or in the front yard of a private residence. They are cheering up the area with their whimsy.

Vanek showed progress and a revised layout for the self-guided tour map. He hopes to have a near final version at the next EACC meeting before presenting to the full board.

Lin suggests making the map a scavenger hunt for kids.

8. Lin asked about EACC’s definition of education, what that entailed. Does that include safety preparation or information from LAPD?

Vanek talks about safety walks and suggested contacting LAPD SLO Villery to organize. Also suggested neighborhood watch captain.

Lin: Suggested LADWP presenting some educational workshops for residents, such as their time-charging tier, which can save money on power during off-peak hours. Also interested in water advice, such as for lawns. Lin would like LADWP to come do a seminar or program guest speakers.

Vanek and Lin agree: Get city and maybe state reps to give workshops on their services to educate stakeholders. Create a schedule for the whole year, with one each month.
